The Pat Connaughton Foundation was founded in 2016 with the mission of creating access to athletics for the next generation of student athletes through **Clinics, Courts, and Character**. The PCF focuses on teaching them the translatable life skills sports teach us - hard work, teamwork, leadership, accountability, and discipline.

Since the start of the **Courts** initiative, the foundation has completed 6 courts and impacted 20,000+ student athletes.

To be eligible for funding from the Pat Connaughton Foundation, organizations must:

- Provide services that further the mission of the Foundation in the areas of Youth Education, Health/Wellness/Athletics for Youth and/or Community Development targeting youth and family.
- Be tax-exempt, either as a federally determined 501(c) (3) entity or as a unit of government and in good standing for the most recent two years.
- Submit the grant application with all required information (only one grant application allowed per grant cycle).
- Have submitted a final evaluation with outcomes for all prior grant awards within three months of the project's completion.
- Be willing to adhere to a site visit and a regular reporting cycle (data, photos, testimonials).
- Be open to 360-degree feedback.

The Pat Connaughton Foundation generally will not fund:

- Organizations with less than 2 years of history
- Individuals
- Endowment or reserve funds
- Debt retirement or operating deficits
- Lobbying or legislative activities

Section 2: Total submission for Section 2 should not exceed 5 pages.

Description of Applicant Organization

Summary of Program / Project Description: summarize the program or project for which the organization is seeking funding. Include key components to project, full timeline, ways Pat Connaughton Foundation logos/marks can be included, proposed outcome statements, the number of people involved in the project, collaborating partners.

Project or Program Impact: describe further the intended impact of the program or project or general issues that will be addressed. Define the communities benefiting from the work and estimate the number of persons served. Additionally, outline ways your project will expand or complement existing community services, plus any arrangements to collaborate with other organizations. Briefly describe the activities and/or strategies to accomplish the proposed outcomes. If applicable, describe ways in which the PCF organization can interface with a project / program. Graphics or infographics are encouraged.

Proposed Outcomes and Outcome Indicators: in your proposal, identify expected outcomes and provide any available history of success of the program / project. Specify the time period for measurement and the measurable indicators you will use to determine whether the outcomes have been achieved.

Funding Plan for Proposed Program / Project: describe the financial plan for the proposed program or project. Identify how the funds requested would be spent (i.e., which specific line items of your budget). Indicate if the grant you are requesting would be used as a match or to leverage other sources of revenue. Describe how a grant from the Pat Connaughton Foundation would be recognized.

Program Budget: submit a line-item budget (sample format shown on the following page) covering all projected expenses. Additionally, submit an income budget that identifies all funding sources (other foundations, corporations, individuals, etc.) for the project. Please note whether each other's funding source is secured or anticipated. The amount of total expenses must equal the amount of total funding sources.
